AGENCY REPORT Summary Statistics From All Sites



BIRTH PARENT RECRUITMENT

Birth parent recruitment began with the agency approximately 8 weeks post-placement. A staff member from the agency, typically the birth parent's social worker or counselor, contacted eligible birth mothers and birth fathers to provide them with information about the study. If the birth parent was interested in learning more about the study, the agency staff member collected their contact information and passed the information to the study recruiter. Typically within a week, the study recruiter contacted the birth parent to provide them details about participating in the Early Growth and Development Study. If the birth parent decided to participate, s/he was sent a set of Informed Consent forms and the scheduling process began for the first in person interview. Across the United States, agencies attempted to contact more than 1500 birth parents. In total, the Early Growth and Development Study recruited 520 birth mothers and 149 birth fathers into the study.

BIRTH PARENT DATA COLLECTION

Birth parent participants were asked to complete two in-person interviews with the Early Growth and Development Study. On average, the first interview occurred 3-6 months post-placement and the second interview occurred 16-18 months post-placement. Before the in-person interview, the birth parent was mailed a booklet of questions to complete on his/her own. An interviewer from the Early Growth and Development Study met with the birth parent at a location that was comfortable to the participant. We often met at homes, but also in the community at the library or a local coffee shop. The in-person interview lasted approximately 2.5 hours. During this interview, birth parents were asked a series of questions by the interviewer and the information was entered into a computer. Participants also completed computer-assisted questionnaires by themselves. Birth parents were compensated \$100 for their time and efforts completing the booklet of questions and the in-person interview.

Birth parents also completed brief telephone interviews at 12, 22, 30, and 42 months post-placement. The phone interviews provided our staff with the opportunity to stay in touch with the birth parents in between and after the in-person interviews.

BIRTH PARENT DATA

The data that is presented in the following report was primarily collected from birth parents during the first in-person interview. Some data were also collected at the 12 month post-placement telephone interview. This data set includes responses from 517 birth mothers (presented in red font) and 146 birth fathers (represented in blue font).
